Summary of Facts in Dispute:

In 1999 I filed a Submission to the Truth and Reconciliation Commission (“TRC”), promising to donate my inheritance to the TRC; in support of sincere – racial, religious, class and gender – reconciliation in South Africa. Since 1999 I have donated my ego/eco literacy and Radical Honoursty communication skills and labour in support of sincere peacenik / honourable warrior – aka sincere racial, religious, class and gender aka End the Abel and Kane Cold War – reconciliation negotiations. Request confirmation as to TRC dis/agreement re: EoP sincere peacenik legal definition. If disagreement: Notice of withdrawal of inheritance TRC offer.

Relief Requested:

If TRC response to EoP sincere peacenik / honourable warrior legal definition – as per George High Court application: H 111/19: Lara Johnson vs Lindiwe Sisulu and Eight Others [Annex A1. pp.70] Ecology of Peace UN Resolution [Annex A1. pp 25-67/70]; is general

[A] Agreement; TRC officials are requested to: [A1] Submit their scientific and/or cultural law error edits and/or KISS: Keep it Simple Stupid language clarification edits; once resolved; &/or; [A2] Submit their own EoP OKC TRC Mandate Oath Statements [Annex A2] into the LJ v LS court record; and monitor S.African and international organizations submissions of EoP OKC TRC Mandate Oath statements into the LJ v LS court record; to provide a mandate for LJ v LS respondents to authorize the filing of EoP UN Resolution to UN General Assembly to implement Ecology of Peace Scientific and Cultural law as binding international law; &/or [A3] If EoP UN Resolution is not authorized into binding international law; to [A3a] take notice of withdrawal of inheritance offer to TRC; to use funds for No EoP OKC TRC: Lara and Tim Siberia Assisted Suicide; [A3b] if required: monitor No EoP OKC TRC: Lara and Tim Siberia Assisted suicide negotiations; or;

[B] Disagreement; TRC officials are notified as per: [A3a]: withdrawal of 1999 TRC offer.
